POTTS HILL TO ALEXANDRIA TRANSMISSION CABLE PROJECT COMMUNITY NOTIFICATION

Underbore at Muir Road, Hume Highway and Hillcrest Avenue, Greenacre

TransGrid is installing a new underground electricity cable from Potts Hill to Alexandria. The Powering Sydney's Future project will help ensure a safe, reliable and affordable energy supply for Sydney's CBD and surrounding areas. You can view a map of the cable route at www.transgrid.com.au/psf

Work to complete an underbore at **Muir Road, Hume Highway and Hillcrest Avenue, Greenacre**, is due to start from **Thursday, 12 November 2020**, and will take around five to six weeks, weather and ground conditions permitting. Some of this work needs to be done outside standard construction hours.

We will set up two site compounds on Muir Road and Hillcrest Avenue, on either side of Hume Highway (see map overleaf).

Work activities

- > Installing temporary fencing and safety barriers.
- > Tree trimming to create a safe distance from plant and equipment (conducted by a trained arborist).
- > Drilling under the road using a drill rig.
- > Excavating a pit.
- > Pulling conduits (plastic pipes) through the underbore.
- > Temporarily restoring the road surface to allow normal traffic flow.

Our team will return at a later date to undertake trenching work along Muir Road and Hillcrest Avenue. Permanent restoration and line marking of the road and any impacted areas will take place after the new cable has been pulled through. We will write to you again before these next stages of work.

Work hours

The work will be carried out on day shifts, **Monday to Sunday, 7am to 6pm** and on three nights a week, including **two consecutive shifts between Sunday and Tuesday night and one shift on Thursday night**.

How will the work affect you?

- > The work will generate some noise, which we will make every effort to keep to a minimum. We aim to undertake highly noise intensive works before midnight wherever possible.
- > There will be a temporary loss of street parking while work is in progress. This includes around 180 metres of parking on Muir Road and around 40 metres on Hillcrest Avenue.
- > There will be temporary lane closures to ensure the safety of workers, road users and residents, although two-way traffic flows will be maintained. Traffic control will be in place to safely direct traffic around the site.
- > Road users may experience temporary delays in accessing local properties.
- > If we anticipate your driveway access may be disrupted, we will inform you in advance and discuss arrangements.

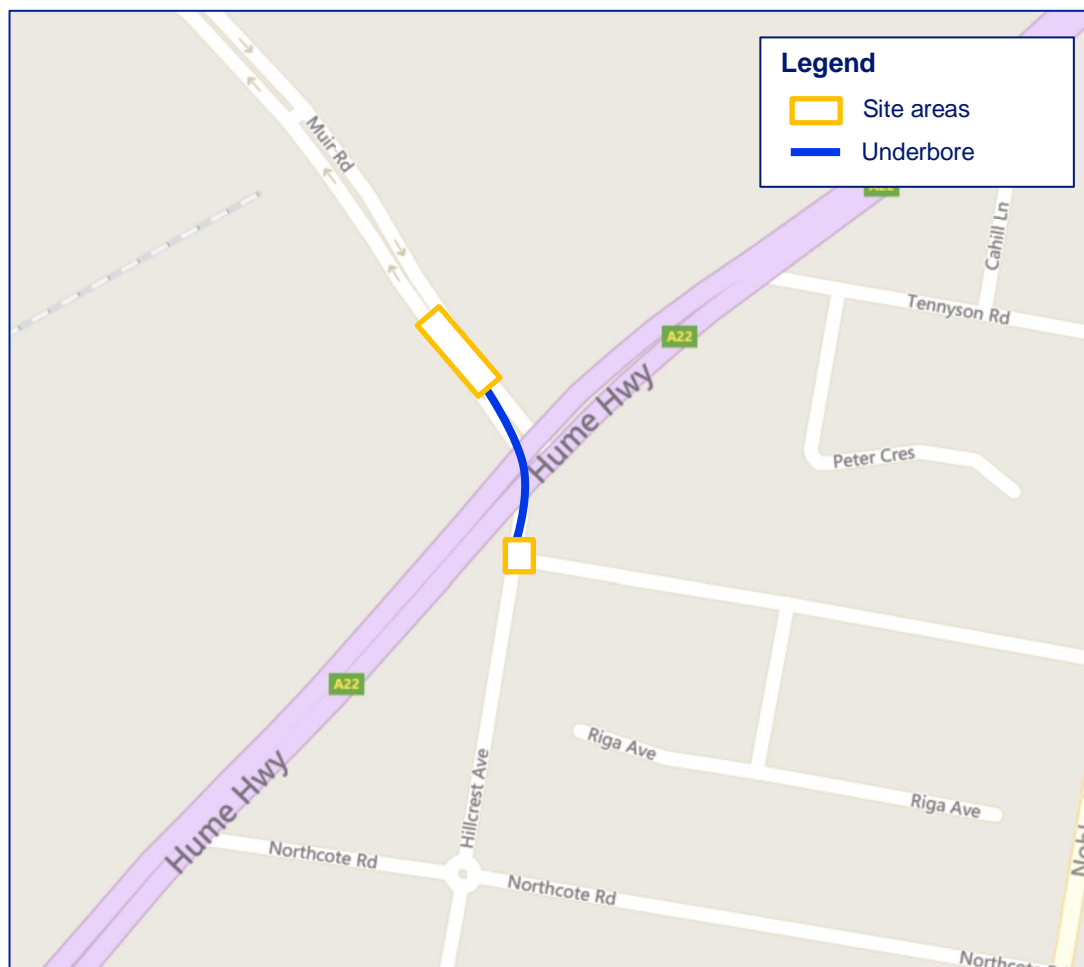
