POTTS HILL TO ALEXANDRIA TRANSMISSION CABLE PROJECT COMMUNITY NOTIFICATION

Investigation works at Holden Street and Second Street, Ashbury

A new transmission cable will be installed from Potts Hill to Alexandria. The Powering Sydney's Future project will ensure a safe, reliable and affordable electricity supply for Sydney's CBD and surrounding areas. You can view a map of the cable route at www.transgrid.com.au/psf.

Investigation works at the intersection of **Holden Street** and **Second Street**, **Ashbury** will start from **Monday**, **4 January 2021** and may take up to one week to complete, weather and ground conditions permitting (see map overleaf).

Work will take place in the highlighted area, however access will be maintained in both directions.

Work activities

The investigations will involve:

- > Scanning the road for existing services, such as gas and water.
- > Cutting the road surface with a concrete saw, excavating a trial hole 1.5 metres x 0.5 metres x 1.9 metres deep, using an excavator and vacuum truck and then refilling the excavation and resurfacing the road.

Work hours

The investigation works will be completed during standard construction hours, which are **7am – 6pm**, **Monday to Friday** and **8am – 1pm**, **Saturdays**.

How will the works affect you?

- > There will be a temporary loss of street parking (typically around four car spaces) at each work location while works are in progress.
- > There will be temporary lane closures to ensure the safety of workers, road users and residents. Traffic control will be in place to safely direct traffic around the work site.
- > Access to properties will be maintained at all times unless we make alternative arrangements with you in advance.
- > These works will generate some noise. However, our crews will seek to limit these impacts as much as possible.


