

What We Heard Report HumeLink EIS Webinars

30 November 2022 - 9 December 2022

Purpose

The purpose of the 'What We Heard Report' is to capture and share information and issues discussed at key engagement events. The reports are published on the project website for those not able to attend an engagement event, as a record of engagement and to provide transparency of items discussed during the forum. They are also passed onto the project team for consideration during project development.

Summary

As part of the development of the Environmental Impact Statement (EIS) for HumeLink, the community engagement team delivered five webinars to 39 attendees during November/December 2022. These sessions aimed to share project information with community members and stakeholders and seek their feedback by:

- Providing clear and timely information on the projects' EIS and relevant technical reports
- Introducing the project team and technical specialists
- Establishing a channel for community and stakeholders to raise questions and concerns
- Encouraging feedback on the project and the engagement to date
- Offering an opportunity for stakeholders to provide input on what specialist studies they wish to hear more about.

The webinars provided an overview of the project and approval process. They are the first in a series of webinars designed to provide information on each of the EIS technical studies in the lead up to the EIS exhibition.

The sessions were widely promoted via the HumeLink newsletter distributed to more than 16,000 locations, Electronic Direct Mail (EDM) to more than 600 email subscribers, on HumeLink's webpage and via social media. Attendees registered to the webinars through digital links located on HumeLink's webpage. The webinar sessions were hosted on Zoom.



Key themes – raised by attendees

- Planning and approvals timeline, including public submissions during the EIS exhibition period
- Project impacts and mitigation during construction and operation including visual impacts and amenity, bushfire risks and impacts on local tourism.
- Management of transmission lines
- Undergrounding, including whether the undergrounding will be considered in the EIS
- Electric and Magnetic Fields (EMF)
- Tower design
- Community investment and social legacy opportunities
- Upcoming community engagement opportunities.
