Dear Resident,

As part of the HumeLink East Project, we are proposing to undertake some out of hours work at the Faulder Avenue Facility to minimise community impacts, improve worker safety, and complete construction more efficiently.

We are seeking your agreement to extend working hours at the site on the weekend as outlined below. A schedule of the proposed activities is attached.

Proposed Out of Hours Work

Current approved working hours:

- Monday to Friday: 7:00am–6:00pm
- Saturday: 8:00am–1:00pm

Extended working hours:

- Saturday 7:00am 6:00pm
- Sunday: 8:00am–6:00pm

Extending work hours will help us undertake gravel stabilisation at the Faulder Avenue Facility by 13 July 2025, thereby reducing the overall period of disruption to the local community.

All out of hour's activities will be closely monitored for compliance with noise and environmental management plans.

What to Expect

A noise assessment has identified that your property may experience some noise impacts during these activities.

Out of hours work will involve:

There will be an increased number of construction vehicles across the project area during our work. The work will involve the use of machinery which may generate some noise including various trucks and project vehicles, smooth drum roller, pad foot roller, soil stabiliser, graders.

To assist with mitigating any potential noise impacts, there will be a limited amount of machinery working together at any given time during this work. Machines will be shielded, where possible, and turned off when not in use. Machinery and equipment may generate dust, noise and vibration. We will make every effort to minimise impacts by:

Minimising the number of machines/vehicles to be used

- Ensuring all machinery and vehicles are maintained and serviced
- Turning off machinery and vehicles when not in use

- Fitting equipment with devices to minimise noise
- Monitoring dust, noise and vibration to manage any potential impacts and change our work if required.
