POTTS HILL TO ALEXANDRIA TRANSMISSION CABLE PROJECT

COMMUNITY NOTIFICATION

Restoration of traffic infrastructure on Seventh Avenue, Campsie

TransGrid is installing a new underground electricity cable from Potts Hill to Alexandria. The Powering Sydney's Future project will help ensure a safe, reliable and affordable energy supply for Sydney's CBD and surrounding areas. You can view a map of the cable route at www.transgrid.com.au/psf.

As you will probably be aware, TransGrid has completed a number of work activities at Seventh Avenue, Campsie. We plan to return to Seventh Avenue, between Fifth Avenue and Beamish Street, from **Monday 23 August** to restore traffic infrastructure (the roundabout at Sixth Avenue, speed humps and traffic islands). This work is expected to take around **two weeks** to complete.

The road surface impacted by our project work will be restored by City of Canterbury Bankstown Council on TransGrid's behalf. You will be advised by Council (or its contractor) at least 48 hours prior to work starting in Seventh Avenue.

Work activities

- > Installing temporary fencing and safety barriers around the work site.
- > Delivering plant and equipment to site.
- > Trimming trees to create a safe distance from plant and equipment (directed by a qualified arborist).
- > Using a pump/vacuum truck to remove water as required.
- > Restoring the roundabout, speed humps and traffic islands.
- > Line marking the road where required.

Work hours

Work hours are 7am to 6pm Monday to Friday and 8am to 1pm on Saturdays.

How will the work affect you?

- > Seventh Avenue will be temporarily closed to through traffic between Fifth Avenue and Beamish Street. Access for residents will be maintained.
- > A stop/slow traffic configuration will be in place on Sixth Avenue near Seventh Avenue.
- > Some work activities will be noisy but we will make every effort to keep noise to a minimum.
- > There will be a temporary loss of street parking. We will endeavour to maximise street parking where possible.
- > An alternative route will be provided if any diversions or closures of pedestrian pathways are required.
- > Residents and businesses may experience short delays to access properties.
- > Driveway access will be maintained where possible. If we anticipate that access will be disrupted for an extended period, we will inform you in advance.


