POTTS HILL TO ALEXANDRIA TRANSMISSION CABLE PROJECT COMMUNITY NOTIFICATION

Cooks River and Lees Park Underbore: between Harmony Street / Hay Street, Ashbury and Lindsay Avenue, Campsie

TransGrid is installing a new underground electricity cable from Potts Hill to Alexandria. The Powering Sydney's Future project will help ensure a safe, reliable and affordable energy supply for Sydney's CBD and surrounding areas. You can view a map of the cable route at www.transgrid.com.au/psf.

Work to drill a bore beneath **Cooks River and Lees Park, Campsie / Ashbury**, is due to start from **Tuesday 16 March** and will take around **seven weeks** to complete, weather and ground conditions permitting. We will set up three site compounds: Harmony Street, Ashbury; Hay Street, Ashbury; and Lindsay Avenue, Campsie. This will result in a temporary loss of street parking and traffic changes. Please refer to the map overleaf for the location of the site compounds and underbore.

Work activities

- > Installing temporary fencing and safety barriers.
- > Trimming trees to create a safe distance from plant and equipment (conducted by a trained arborist).
- > Excavating pits in the site compounds on Lindsay Street and Harmony Street.
- > Drilling under the Cooks River using a drill rig located in the site compound on Lindsay Street.
- > Assembling and then pulling conduits (plastic pipes) through the underbore.
- > Digging a trench about two metres wide using an excavator and installing conduits (pipes) in the trench.
- > Temporarily restoring the road surface to allow normal traffic flow.

Work hours

Work hours are **Monday to Friday 7am to 6pm, and Saturday 8am to 1pm.**

How will the work affect you?

- > Work will be noisy at times, but we will make every effort to keep noise to a minimum.
- > **Harmony Street** will be closed at times to through traffic while pipes are installed. Traffic detours will be in place for the safety of workers and road users. Harmony Street will remain open to local residents under traffic control.
- > There will be a temporary loss of street parking of around 260 metres on **Hay Street** for the duration of the work. There will also be a temporary loss of street parking near the site compounds on **Harmony Street and Lindsay Avenue.**
- > Temporary changes will be made to local property access near the site compound on **Hay Street** and residents will be required to enter and exit their driveways via a 'left in, left out' traffic set up as shown overleaf.
- > There will be temporary lane closures to ensure the safety of workers, road users and residents. Traffic control will be in place to safely direct traffic around the site.
- > Road users may experience short delays in accessing local properties.
- > If we anticipate that your driveway access may be disrupted, we will inform you in advance and discuss arrangements.



What's next

We expect to be working on Lindsay Avenue, Harmony Street and Hay Street until June 2021 but work will not be continuous during this period. Following this underbore work (about seven weeks), we will continue with installing and joining cables at the recently installed joint bay, installing a second joint bay and some minor ancillary pits, and temporarily restoring the road surface. We will keep you advised of these activities.

Once all work is complete in the area and the cable is installed and tested, we will permanently restore the road surface.
