POTTS HILL TO ALEXANDRIA TRANSMISSION CABLE PROJECT

COMMUNITY NOTIFICATION

Underbore at New Canterbury Road, Dulwich Hill

TransGrid is installing a new underground electricity cable from Potts Hill to Alexandria. The Powering Sydney's Future project will help ensure a safe, reliable and affordable energy supply for Sydney's CBD and surrounding areas. Work to drill an underbore at **New Canterbury Road**, **Dulwich Hill**, at the intersections of Pigott Street and Herbert Street, is due to start from **mid-December 2020** and will take around four weeks weather and ground conditions permitting. Some of this work may need to be done outside standard construction hours.

We will set up three work areas, one on Pigott Street and two on Herbert Street (see map overleaf).

Work activities

- > Installing temporary fencing and safety barriers.
- > Tree trimming to create a safe distance from plant and equipment (conducted by a trained arborist).
- > Directional boring under the road using a bore rig located in the eastern site compound.
- > Excavating a pit in the western site compound.
- > Pulling conduits (plastic pipes) through the underbore.
- > Digging a trench about two meters wide using an excavator and installing conduits (pipes) in the trench.
- > Temporarily restoring the road surface to allow normal traffic flow.

Our team will return at a later date to undertake trenching work along Piggott Street and Herbert Street. Permanent restoration and line marking of the road and any impacted areas will take place after the new cable has been pulled through. We will write to you again before these next stages of work.

Work hours

We will notify you of working hours at least seven-days before the underbore work starts, including details of any work outside standard construction hours. Work will not occur on public holidays.

How will the work affect you?

- Pigott Street and Herbert Street will be temporarily closed to through traffic during the work. Traffic detours and traffic control will be in place for the safety of workers and road users. Pigott Street and Herbert Street will remain open to local residents under traffic control.
- > The work will generate some noise, which we will make every effort to keep to a minimum. We aim to undertake highly noise intensive works before midnight wherever possible.
- > There will be a temporary loss of street parking while work is in progress. This includes around 120 metres of parking on Herbert Street and around 40 metres on Piggott Street.
- > Road users may experience temporary delays in accessing local properties.
- > There may be temporary closures of footpaths and cycleways, however we will provide an alternative route.
- > If we anticipate that your driveway access may be disrupted, we will inform you in advance and discuss arrangements.
