Discussion: The Inaugural Chair then asked the group to pause and open up for any questions or discussion points. Comments from the group are below: Transgrid needs to ensure that it extends its engagement process for community members who live adjacent to the proposed corridor and within the broader region Members of the CCG noted that there are community members who are currently unaware of the project and potential impacts to their property Landholders who reside adjacent to the proposed corridor also need to receive very targeted information, in the form of a letter as information presented on websites and newsletters could be missed There was concern that information shared to date could be perceived as deceptive with imagery not adequately reflecting the	 Transgrid's community engagement team need to further engage with local community groups and undertake very targeted activities to help disseminate information across the region The community members requested Transgrid consult with the community on the content of the flyers distributed to neighbouring landowners. Future information to use real-life and factual imagery Transgrid is to note that members of the local Aboriginal community would like to be adequately engaged on the process and have better oversight on the engagement that is being undertaken.

4	Orientation to the Humelink Project	About the project and status: Tim gave an overview of the project and its need to the group HumeLink is a critical energy infrastructure project which will see a new 360km 500kV double circuit transmission line connecting Wagga Wagga, Bannaby and Maragle to the existing power network The project is being driven by new renewable generation sources and to increase capacity in the network The Project Assessment Conclusions Report (PACR) was submitted to the AER in July 2021 and subsequent revisions have been undertaken to help refine the project and its corridor. Key definitions To help build understanding and clarification of various matters that will be discussed in the CCG, Sumaya gave an overview and explanation of the key project definitions.	 The key definitions are available in the attached Presentation Transgrid notes that there needs to be broader consultation with community members outside of the corridor Transgrid is to modify its presentation materials to reflect true and to scale information as to not confuse members of the community. Community members requested Transgrid support the communities' dispute with the PACR. Transgrid stated that it is not in a position to do so.
