What is HumeLink?

HumeLink is one of Australia's largest energy infrastructure projects connecting renewable energy sources to the grid, increasing availability and market competition - helping to put downward pressure on energy prices in Australia.

The project consists of 365 kilometres of 500 kV overhead transmission lines connecting Wagga Wagga, Bannaby and Maragle, and new or upgraded infrastructure at four substations.

HumeLink is critical to bringing more affordable, reliable and renewable energy to the grid and is a priority project for the Australian Energy Market Operator (AEMO) and the Commonwealth and NSW Governments. HumeLink is subject to the approval of the Australian Energy Regulator.



Community Information Sessions


Our latest community information sessions were held between Monday 12 February and Friday 23 February 2024.

Members of the HumeLink project team visited 12 locations, holding 15 drop-in sessions with 65 community attendees to allow the community to hear from key members of the project team, ask questions, provide feedback and learn about progress and amendments that will be included in the Amendment Report. In addition to our community information

sessions, the Transgrid project team hosted street meetings with our Remote Access Community Hub (RACH) in Yass, Crookwell, Tarcutta and Batlow.

We understand not everyone is able to join us in-person, so we also held three webinar events to share the project progress and allow the community to ask questions.

The HumeLink team would like to thank everyone who joined us both in-person and online. We appreciate you taking the time to come and speak with us and discuss the project.

What information was available at the sessions?

At the community information sessions, the project team had a series of fact sheets on display about information that will be included in the Amendment Report which we intend to submit to the Department of Planning, Housing and Infrastructure in mid-2024. The three fact sheets that were available are also available on the HumeLink website:

Project team members were also available at these sessions to answer technical questions, providing expertise and support regarding the Amendment Report and refinements.



Transgrid encourages feedback on HumeLink application

The Australian Energy Regulator (AER) has published the Contingent Project Application Stage 2 (CPA2) for Transgrid's HumeLink project, which outlines the estimated project costs and anticipated community benefits for the nation-critical transmission project.

The CPA2 provides details on the specific costings to deliver the HumeLink project, and the significantly increased market benefits to consumers from \$491 million to more than \$1 billion. It also details millions of cost savings to consumers through innovative procurement and project integration planning, including:

- \$85 million for securing long lead equipment (LLE) such as reactors, transformers and conductors through Transgrid's Powering Tomorrow Together (PTT) program
- \$237 million in savings for the design and construction of substations and transmission lines including access tracks under an innovative contracting approach.

Publication of the CPA2 starts AER's official four-week consultation process for this part of the process and will run in parallel with the three-week consultation period for Transgrid's Response to the Material Change in Circumstance (MCC) assessment, which demonstrates that the project remains the preferred option. Feedback received on the draft CPA2, published on Transgrid's website since December 2023, will also be considered by the AER in making its determination.

The CPA2 can be accessed on the <u>AER's website</u>. Submissions are invited and can be made until 3 April 2024. Transgrid also welcomes feedback on <u>the MCC assessment</u>. To share your feedback, email humelink@transgrid.com.au before 3 April 2024.

HumeLink East Business Buzz sessions

The HumeLink East project team recently held Business Buzz information sessions tailored to local businesses and workforce to discuss the opportunities the project will bring to the region. Throughout February, five in-person sessions were held in Campbelltown, Goulburn, Gundagai, Canberra and Oak Flats. More than 140 people attended and key themes of project updates, procurement packages and systems, and employment and training opportunities were discussed over the duration of the sessions.


Community Partnerships Program - grants for community initiatives

Transgrid's Community Partnerships Program offers grants of up to \$5,000 for not-for-profit organisations that are local to our planning, operations, and major project areas. Not-for-profit groups provide a range of invaluable resources for their communities. Our Community Partnerships Program was created to give a boost to the people who live and work in the regions local to Transgrid assets or construction. Since 2020, Transgrid has

awarded grants to more than 60 organisations for a range of initiatives spanning from community infrastructure to workshops, along with inclusivity and accessibility projects. The next round of Transgrid's Community Partnerships Program opens on 25 March 2024. Amendment Report and Submissions Report

As part of the planning approval process, Transgrid is currently preparing an Amendment Report and Submissions Report which will be lodged concurrently with the NSW Department of Planning, Housing and Infrastructure (DPHI).

The Amendment Report outlines several proposed amendments and refinements to the HumeLink project including those made in response to feedback received during the Environmental Impact Statement (EIS) public exhibition in 2023. It will describe the potential impacts of these amendments and refinements and how Transgrid and its Delivery Partners intend to manage and mitigate them. The Submissions Report will present responses to the stakeholder and community submissions provided to the DPHI on the EIS.

The Submissions Report and Amendment Report will cross-reference one another and should be read together. Both documents will be made available on the NSW Major Projects Planning Portal.

Throughout the development of the Amendment Report, the HumeLink project team has continued to engage with local communities and key stakeholders, including with council representatives, government agencies, First Nations stakeholders, landowners and the general community.

During the most recent round of community information sessions in February this year, community members and stakeholders were particularly interested in knowing more about the amendments and refinements included as part of the Amendment Report. Key topics included the proposed worker accommodation facilities, traffic movement and traffic safety during construction and the use of local roads and access tracks. Attendees were also interested in learning about opportunities for local businesses and local workers as well as the positive local economic impact the project may bring.

Later this month, we will share the progress of the Amendment Report assessment with our CCG members, and continue to engage with relevant agencies, councils, landowners, First Nations stakeholders and community members.

A final assessment and determination of the HumeLink EIS, Amendment Report and Submissions Report will be delivered under a bilateral agreement between NSW and the Commonwealth governments. This is a process established to strengthen co-operation and reduce duplication on planning approval matters.

Subject to the NSW and Commonwealth Government planning approvals, construction of HumeLink will start in late 2024 and be completed in 2026.
