
Powering Sydney's Future





Project update Sydney Car Park and Sydney Park Depot, Alexandria

Transgrid is installing a new underground electricity cable from Potts Hill to Alexandria. The Powering Sydney's Future project will help ensure a safe, reliable, and affordable energy supply for Sydney's CBD and surrounding areas. You can view a map of the cable route at www.transgrid.com.au/psf.

As you will probably be aware, Transgrid has completed several work activities on Sydney Car Park and Sydney Park Depot, Alexandria. We thank you for your patience during our work in your area so far. The next and final stage of work involves permanent restoration on Sydney Car Park and Sydney Park Depot, Alexandria.

Works on Sydney Car Park and Sydney Park Depot, Alexandria will start from **Friday 10th March 2023 to Friday 17th March 2023** and will take approximately **1 night** to complete. If the weather forecast is poor, work will be rescheduled to the next available day.

Work activities

- > Delivering plant and equipment to site.
- > Milling the road surface.
- > Laying asphalt.
- > Temporary Line Marking.

How will the work affect you?

Two-way traffic on Sydney Car Park and Sydney Park Depot, Alexandria will be maintained under stop/slow arrangements.

Stop/Slow Road arrangement will be implemented between at Sydney Car Park and Sydney Park Depot at the work zone only to minimise inconvenience, Access for residents/Local Businesses will be maintained. Road users may experience short delays to access local properties.

The work will be loud at times, but we will make every effort to keep noise to a minimum.

Some construction equipment will be temporarily stored on the roadway on Sydney Car Park and Sydney Park Depot, Alexandria. There may be temporary closures of pedestrian crossings, but we will provide an alternative route.

Traffic control will be in place for the safety of pedestrians, workers and road users.
